A statement on the WOC website reads in part:

After discussions with key stakeholders and feedback from industry-leading concrete & masonry associations, World of Concrete made the proactive decision to reschedule WOC 2021 from January to June. The decision to move the dates back several months was not easily reached; however, we felt it was the right choice for all involved.

Registration for WOC 2021 will open online in early 2021.

Due to COVID-19 restrictions, California regional qualifiers for the 2021 National Fastest Trowel and Skills Challenge competitions have not been held. MCAC stands ready to support our California competitors on the national stage as soon as is permissible.

REMINDER! Sexual Harassment Prevention Training Deadline is January 1, 2021



Effective January 1, 2021, all employers of 5 or more employees must provide 1 hour of sexual harassment and abusive conduct prevention training to non-supervisory employees and *2 hours of sexual harassment and abusive conduct prevention training to supervisors and managers once every two years.

That [free training](#) for both non-supervisory and supervisory employees is available online through the California Department of Fair Employment and Housing.

*Employers of 50 or more employees have an existing and ongoing obligation to train supervisory employees within six months of assuming their supervisory position. Beginning January 1, 2021 new supervisory employees in workplaces with 5 or more employees must be trained within six months of assuming their supervisory position.
