COVID Resources Updated

TESTING: On January 26, 2021, Cal/OSHA updated the previously posted <u>frequently asked questions</u> (FAQs) with additional information addressing testing. If your business is seeking testing guidance, visit the <u>Cal/OSHA website</u> for detailed direction. See below for quick links to testing resources.

Q: Where can I find COVID-19 testing for my employees?

- California Department of Public Health
- National Association of County and City Health Officials
- Local health departments
- An employer can partner with a medical provider to establish a testing program

However testing is arranged, employers must ensure employees do not incur any costs for COVID-19 testing.

VACCINES & WHEN TO QUARANTINE: On February 11, 2021, the U.S. Centers for Disease Control and Prevention (CDC) updated materials on its website pertaining to when individuals should quarantine after exposure to someone with COVID-19. Specifically, the "When to Quarantine" page now states that "[p]eople who have been in close contact with someone who has COVID-19 are not required to quarantine if they have been fully vaccinated against the disease within the last three months and show no symptoms." The CDC added similar language to its "When You Can be Around Others After You Had or Likely Had COVID-19" page, stating that "[s]omeone who has been fully vaccinated within the last three months and shows no symptoms of COVID-19" does not need to stay home after having close contact with a person with COVID-19.

While this update may offer welcome news, it conflicts with CDC's
primary guidance
to health departments upon which many state and local requirements and recommendations are based.

What should employers make of these seemingly inconsistent guidance documents? Keep in mind that in many jurisdictions, it is ultimately the guidelines and requirements of state and local public health authorities that control what employers should be doing in their respective jurisdictions.
