COVID: Employer Tax Credits + California's New Paid Sick Leave Tool

The MCAC [March 23 Alert](#) reported on newly-enacted COVID-19

Supplemental Paid Sick Leave (SPSL) for employers of 26 or more employees with the passage of [SB 95](#). Information on how eligible employers may claim COVID-19 related tax credits is now available from the Treasury Department and Internal Revenue Service (IRS). Links to both are below. Note that qualifying leave wages between April 1, 2021 through September 30, 2021 are eligible for federal tax credits. California's Supplemental Paid Sick Leave applies January 1, 2021 through September 30, 2021.
