
UPDATE: Circuit Court Rules Arbitration Agreements Can Be Required as a Condition of Employment



Good news for employers in the on-again off-again issue of employment arbitration agreements! A major reversal by the Ninth Circuit Court of Appeals now says the California law (AB 51 - passed in 2019) banning "forced arbitration" clauses is preempted by federal law and therefore unenforceable.

While this is a win, this is likely not the end of the AB 51 saga. However, it is another significant ruling focused on the importance of arbitration in the workplace. California employers should still seek counsel when implementing arbitration agreements in the workplace due to the complexity and changing landscape related to enforcement of these agreements.
