

HELP WANTED! MCAC to Elect New Board of Directors for 2024/25



What?

Every odd-numbered year, MCAC elects new leadership. The MCAC Board of Directors consists of five positions: President, Vice President, Secretary, Treasurer and Immediate Past President. The Immediate Past President is a non-elected post assumed by the outgoing president. All five board members have equal voting authority. Terms are two years. The 2024/25 term will commence January 1, 2024.

How?

For the first time in the organization's history, *eligible members will have the opportunity to vote for that leadership electronically from the comfort of their offices as

opposed to in-person at a State Meeting. Keep an eye out for your email ballot this fall.

Why?

Board members are the MVPs of the association and nonprofit world. They're not just legally required, they're also critical to ensuring an organization's long-term success and helping guide the organization in its growth. 

Workplace Violence Prevention Rules Coming to California Employers -- One Way or Another!

In the <u>2Q 2023 MCAC Newsletter</u>, we reported on <u>SB 553</u> – a bill advancing through the legislature that would require every employer with 1 or more *persons in service*, to establish, implement, and maintain, at all times in all of the employer's facilities, a workplace violence prevention plan (WVPP) as part of the injury and illness prevention program (IIPP) or maintained as a separate document. Employers would also be required to provide effective training to employees that addresses the workplace violence risks that employees may reasonably anticipate to encounter in their jobs, among other requirements.

As SB 553 moves through the legislature, Cal/OSHA continues its work on a <u>workplace</u> <u>violence regulation</u> that has been under development for several years. However, the pace and scope of the Cal/OSHA standard has not been satisfactory to labor advocates. So, labor unions sponsored SB 553 to sidestep the regulatory process and speed up implementation.

What does this dual-pronged approach mean for California employers? It means that workplace violence is currently one of the hottest issues facing California employers and, one way or the other, it is likely to bring compliance requirements possibly as early as next year.

MCAC is exploring a WVPP template that would be available to members. We continue to follow this issue closely and will keep you apprised of developments.
