On September 20, 2023, Governor Gavin Newsom signed Senate Bill No. 553 (SB 553) into law, which requires almost all California employers to implement a comprehensive workplace violence prevention plan by July 1, 2024.

While SB 553's provisions are effective July 1, 2024, it is anticipated that Cal/OSHA will begin to focus on workplace violence prevention before the compliance deadline and has already cited employers for failing to adequately address the issue.

New Laws for California Contractors and Employers: MCAC 2023 Issues on the Radar UPDATE

California's legislative session wrapped September 14, 2023. The Governor's deadline for action on bills was October 14. <u>Here</u> is a recap of the issues on MCAC's watch list and where they are

now.

The Big 3:

- <u>SB 553</u> Occupational Safety: Workplace Violence Requires almost all California employers to implement a comprehensive workplace violence prevention plan by July 1, 2024.
- <u>SB 616</u>- Sick Days: Paid Sick Days Accrual and Use Increases required employer provided paid sick leave from 3 days (or 24 hours) to 5 days (or 40 hours).
- Criminal History Regulation Updated <u>As of October 1, 2023</u> California's Fair Employment and Housing Act (FEHA) has been <u>updated</u> with new requirements for how California employers with five or more employees can use criminal history information when making employment decisions.

Bills are effective January 1, 2024 unless otherwise indicated.
