Funding for CARB Diesel and Zero Emission Compliance Expanded

California Air Resources Board (CARB) has announced updates to the Carl Moyer Voucher Incentive Program (VIP). The Carl Moyer Program provides grant funding to help small fleets (10 vehicles or less) with costs of engines, equipment and other technologies that achieve emission reductions that are surplus (i.e., early and/or in excess of what is required by regulation).

Voucher funds have traditionally supported the transition of small fleets to the 2010 engine model year emission standard per the Truck and Bus Regulation.

<u>NEW in 2022</u>

Additional funding for replacement vehicles meeting the zero-emission standard up to \$410,000 per heavy heavyduty vehicle has been added to help meet California's zeroemission goal for medium and heavy-duty vehicles by 2045.

Applications are reviewed on a first-come, first-served basis, and applicants are notified within 15 business days upon receipt of their application.

Resources for Contractors: Contractors Licensing Center

Ever forget to renew your license on time? Or, maybe your Responsible Managing Officer is a generation (or two) behind? And you need a fix ASAP! These are the kinds of paperwork headaches that can lead to payments being withheld, penalties being assessed -- not only from the Contractors State License Board (CSLB) but from project owners -- and all the domino effect of complications when you have your company resources and your good name on the line.



MCAC has worked with <u>Contractors Licensing Center (CLC)</u> principal, Phil Vermeulen, on issues of impact to the construction industry over many years. Phil has participated in CSLB proceedings since 1981. I have witnessed Phil's team at Contractors Licensing Center work miracles on behalf of contractors. So, if you ever need a hand with a licensing issue, keep CLC as a valuable tool in your toolbox.

What does CLC do?

- Contractor licensing, application preparation and exam assistance in all fifty states. Expedites available in California (must provide substantiation)
- Assistance with complaints filed against your license
- Incorporations and other filings with the Secretary of State in all fifty states
- Obtaining your employer Identification Number (EIN) through the Federal Government

CARB Offers FREE Training on New Zero Emission Programs and Regulations

The California Air Resources Board (CARB) has several new regulatory programs to help the State become carbon neutral in the future. These programs are going through the public process designed to get input from people and industries affected by the eventual requirements. MCAC has been participating in and reporting on these public workshops since Governor Gavin Newsom's September 2020 **Executive Order N-79-20**. But CARB wants to hear from end users. In furtherance of that goal, CARB has launched a NEW class to cover the requirements of existing regulations and the new programs that will eventually be in effect.
