## California Subcontractor Rights to Resolve Out-of-State Disputes

It is not uncommon in the construction industry for an outof-state general contractor to include a provision in a subcontract requiring a California subcontractor to resolve disputes outside the state of California, even though the work is to be performed within California. Fortunately, most California subcontractors are immune from this tactic. California law generally prohibits clauses requiring subcontractors to travel outside California to resolve construction disputes.

### Zero Emission Rules on the Fast Track

\*As previously reported, The <u>California Air Resources Board</u> (CARB) is developing regulations to move California vehicles and equipment to electric (aka zero emission) by 2045:

- 2035 Passenger vehicles
- 2045 Commercial trucks and construction equipment

MCAC has participated in multiple CARB workshops addressing these regulations and two common themes have emerged:

- 1) These rules are moving forward. There is no 'if'. Only 'when'. Hence, the *head in the sand* strategy is not going to work.
- 2) The requirements could kick in sooner than we think...and apply to smaller fleets than originally presented.

Some of the proposals under consideration:

- Medium and heavy-duty vehicles complete the transition to ZEVs by 2036 instead of 2045.
- 100 percent ZEV sales begin in 2036 instead of 2040 model year.
- Fleets with as few as 10 vehicles may be subject to the rules instead of those with 50 or more vehicles. Fleets subject to the rule include those with Gross Vehicle Weight Rating (GVWR) greater than 8,500 lbs (such as Dodge Ram 2500, Chevrolet Silverado 2500, and the F-250, light duty Class 2 and above).

The next CARB workshop is scheduled for April 27. MCAC will continue to follow and report developments.

## **Prevailing Wage Holidays**

Effective January 1, 2023, California added four new official state holidays to Government Code Section 6700:

- The date corresponding with the second new moon following the winter solstice, or the third new moon following the winter solstice should an intercalary month intervene -Lunar New Year
- April 24 Genocide Remembrance Day
- June 19 Juneteenth
- Fourth Friday in September Native American Day

Holidays upon which the general prevailing hourly wage rate for Holiday work shall be paid, shall be all holidays in the collective bargaining agreement, applicable to the particular craft, classification, or type of worker employed on the project, which is on file with the Director of Industrial Relations. If the prevailing rate is not based on a collectively bargained rate, please refer to Labor Code Section 1773 and the following amended Government Code Section 6700 for the required holidays.

## CMU Checkoff Assessments Start April 1



After more than a decade in the making, the Concrete Masonry Unit (CMU) checkoff program assessment begins April 1, 2023. Chances are you

have already received notice of the assessment from your block producers. The checkoff rate is a penny per block sold and only at the first point of sale. Checkoff is a mandatory program for all block producers nationwide and is administered by the United States Department of Commerce. The Program is governed by a <u>Board of Directors</u> who will ultimately steward the industry funds. <u>Regional Advisory Committees</u> (RACs) are responsible for developing local and regional programs for submission to the Board for investment consideration. California falls under Region 5 and is represented, in part, by: Chair: Joe Kerrigan, Basalite Building Products, LLC
