## Sexual Harassment Training Deadline Extension Possible

Possible relief is pending in the California legislature. <u>SB 778</u> could potentially provide more time for employers to comply with the new sexual harassment training requirements that became effective on January 1 this year.

SB 778 seeks to 'clean-up' the timing of sexual harassment training requirements of last year's SB 1343. Effective January 1, 2019, SB 1343 mandated that California employers with 5 or more employees provide 1 hour of sexual harassment and abusive conduct prevention training to nonsupervisory employees and 2 hours of such training to all supervisors before January 1, 2020. Training is required once every two years and within six months of hire or promotion.

If passed, SB 778 would give employers until **January 1, 2021** to meet the new training requirements and further clarifies that employers that already provided the training in 2019 need not do so again for two years.

SB 778 also gives the Department of Fair Employment and Housing (DFEH) additional time to develop the FREE online training for employers to use as required by SB 1343.

While this training timeline fix is not a done deal yet, it has already passed the Senate without a single no vote and is expected to receive Assembly approval in the coming weeks. The bill is an "urgency" measure which means it will go into effect immediately if signed by the Governor.

MCAC is working with Saint Moore Insurance Agency (SMIA) to bring FREE supervisor sexual harassment training to you. Stay tuned for details!

**Answer:** I have! He paid a visit to the office on June 13, and I am honored to report Ryan has had some very memorable milestones recently.

Many of you are very familiar with our founder, Ryan M. O'Brien, but, for those of you who may not have heard the stories, here is a little background. Ryan comes from a family of masons that dates back to 1854. He had his own mason contracting business from 1948 to 1962 and, ultimately, gave his company up to found MCAC (then CCMCA) in 1963. ## Cal/OSHA Penalties Increase for 2019

In 2015, the Federal Civil Penalties Inflation Adjustment Act Improvements Act of 2015 ("Inflation Act") directed agencies to do two things to bring penalties in line with inflation and make up for the lack of previous increases: 1) implement an initial "catch-up" adjustment which saw the biggest increase in OSHA penalties since 1990 and 2) make subsequent annual adjustments for inflation each year by January 15.

States with <u>state plans</u>, like California, are required to implement programs that are "at least as effective" as federal OSHA and are given six months to do so. Expect <u>Cal/OSHA penalties to increase accordingly</u> for 2019 and reflect, at least, the figures below.

Repeat and Willful Violations - Maximum	132,598	124,709	70,000
Serious Violations - Maximum	25,000	25,000	
Serious Violations - Minimum	18,000	18,000	

REMINDER: Penalties are permitted to increase annually based on the Consumer Price Index.
