The **State of California** recognizes only two certifications: Small Business Enterprise (SB or SBE) and Disabled Veteran Business Enterprise (DVBE). There is also a new subsect of the SB certification for Public Works businesses, SB-PW that allows public works businesses a higher revenue limit to become certified as small. The Procurement Division at the California Department of General Services (DGS) is the central purchasing authority for all state departments and local government agencies.

Federal Contractors Must Have COVID Vaccine by December 8, 2021

On September 24, 2021 new federal <u>Guidance</u> requires that contractor and subcontractor employees at all tiers be fully vaccinated against COVID-19 no later than December 8, 2021, with very few exceptions. This includes outdoor workplaces. The Guidance makes clear that contractors must comply regardless of state or local laws to the contrary. Contractors should:



- carefully consider added costs of compliance with this mandate prior to procuring affected projects, and
- carefully document all added costs or delays associated with compliance should you seek a contract adjustment.
