# MCAC Remembers Industry Icon, Perry O'Laughlin



It is with great sadness and shock that we say goodbye to PTS Masonry owner, Perry O'Laughlin. Perry had a fatal heart attack Sunday, December 16 while at his duck club.

Perry's affiliation with MCAC dates back to 1989 and he was *always* a resource when needed generously sharing his vast experience in the masonry industry. He volunteered to be a technical advisor during two rounds of silica regulation hearings and often served as a judge at local apprentice and bricklayer competitions helping to guide young masons. Perry was also a skilled mason that displayed his talents when he competed in the Basalite "Seniors Fastest Trowel" contest and won 1st place every time he competed...but remained humble despite his impressive resume. He was also an avid softball player and hunter that loved the outdoors -especially the camaraderie with fellow sportsmen. His accomplishments and interests are too many to enumerate, but when your friends describe you by saying,

"His friendliness was contagious and you just appreciated his honesty and bright outlook. Everyone liked Perry, how could you not." Then, I would say you have done something very right.

Perry will be missed, for sure, but remembered fondly.

In hollow Concrete Masonry Unit (CMU) design and construction, the term f'm has been perceived as meaning different things, such as the actual strength of masonry, the tested strength of masonry, or even the strength of the CMU. The term, f'm, is defined in TMS (The Masonry Society) 402, Building Code Requirements for Masonry Structures as:

### Diesel Deadlines for On-Road and Off-Road Fleets



#### January 1, 2019 - On-Road Vehicle Retirement Deadline

Light vehicles (14,001-26,000 lbs GVWR) with Engine Model Year 1999 need to be replaced or repowered to a 2010 or newer model year engine.

#### January 31, 2019 - On-Road Fleet Changes and Flexibility Options Reporting Deadline

On-road diesel fleets are required to report bought or sold vehicles, installed filters, and upgraded engines within 30 days of the change. Fleets seeking flexibility compliance options like those listed below must renew that compliance option and report mileage (if applicable) by January 31, 2019.

- NOx Exempt Area Operation
- Low-Use
- Manufacturer Delay (Must email trucrs@arb.ca.ogv to opt in. See Online User Guide for details.)
- Heavy Crane Phase-In Option
- Low Mileage Work Truck Option w/ PM Filter (Only applies to vehicles with pre-1996 engines until replacement deadline)

<u>TRUCRS</u> is the online reporting system for the On-Road (aka Truck & Bus) Diesel Regulation. View the <u>TRUCRS User Guide</u>.

#### March 1, 2019 - Off-Road Reporting Deadline

Off-road diesel fleets are required to complete annual reporting and submit a Responsible Official Affirmation of Reporting (ROAR) form or e-ROAR by March 1, 2019. You can complete this requirement starting January 1, 2019. If you need a refresher, the California Air Resources Board (CARB) is offering two webinars in January. Register at the links below. \*DOORS is an online tool designed to help fleet owners report off-road diesel vehicle inventories and actions taken to reduce vehicle emissions to the California Air Resources Board (CARB), as required by the Off-Road Diesel Regulation.
